

ABOUT CF ALBERTA



Community Futures Alberta (Community Futures Network of Alberta - CFNA)

Community Futures Alberta is the provincial association representing 27 Community Futures offices across rural Alberta. CFNA manages shared funds and provincial initiatives on behalf of its members, while the Community Futures offices deliver loans and business supports directly to rural entrepreneurs. We govern ourselves as a provincial non-profit and provide leadership, coordination, and advocacy for the Community Futures network in Alberta.

Each Community Futures office is a locally governed, non-profit organization that provides small business loans, coaching, and economic development support to entrepreneurs and communities. Together, these offices form a vital grassroots network that supports rural growth.

As part of the Community Futures Network of Canada, Community Futures Alberta is connected to a national network of 267 Community Futures offices, all working together to strengthen rural and remote communities from coast to coast. Our mandate is to support small business development and rural economic diversification across Alberta. We actively work with community and business leaders to foster rural growth and are partners in building vibrant, sustainable communities.

At the provincial level, Community Futures Alberta:

- Supports member offices through training, professional development, and communications.
- Leads & Coordinates network-wide programs and initiatives.
- Represents & Advocates on behalf of the network with funders, governments, and stakeholders.
- Builds Connections through events and collaboration opportunities that bring together boards, managers, and staff.

For more than 30 years, Community Futures has been a cornerstone of economic development in rural Alberta. Through Community Futures Alberta's leadership and coordination, our network continues to work collectively to empower entrepreneurs, strengthen communities, and drive sustainable economic impact.

MESSAGE FROM THE EXECUTIVE DIRECTOR

Since joining the Community Futures Network of Alberta as Executive Director in April 2024, I've had the privilege of working with a Board that brings a wide range of perspectives, a newly restructured staff team, and the Community Futures offices across Alberta. This has been a year of rebuilding, with every staff member either new to the organization or new in their role. Together, we've focused on learning, strengthening capacity, and moving key projects forward to better serve our member offices.

I want to thank our Chair, Russell Crook, for his leadership, as well as the Executive, our committees, and the Board for their dedication to CFNA. I am especially grateful to our staff team, who, along with a new contract bookkeeper, stepped into new roles and responsibilities this year. Their contributions to member services, communications, training, and operations have been vital as we rebuilt our team.

Over the past year, I've also had the privilege of building a strong relationship with PrairiesCan, and of representing CFNA through participation on both the CF Pan West Network and the Community Futures National Board. These connections are vital in ensuring Alberta's voice is heard and that our work stays aligned with regional and national priorities.

The Governance Review, led by the Board Development and Governance Committee, has been one of our biggest priorities. This work is about ensuring CFNA has the right structure, clarity, and practices in place to govern effectively on behalf of its members. It has focused on strengthening director elections, improving accountability, and creating a framework that supports strong leadership and decision-making. The decision on how to move forward now rests with our members, and once we receive that direction, there will be important work ahead to put the changes into action.

The Entrepreneurs with Disabilities Program (EDP) experienced unprecedented demand this past year, reaching full capacity for both coaching and special projects. As a result, the program was temporarily closed in early spring and re-opened in April so that we could conduct a review, informed by member feedback from roundtables held in late 2024, and fine-tuned to ensure it continues to meet the needs of entrepreneurs across Alberta.

Other highlights include the return of the CFLIP Committee, rollout of the Training Review Project with orientation videos, new HR and Business Analyst toolkits, and upcoming marketing webinars, as well as the next phase of our member training program. We also delivered a successful Spring Training event and are reviewing the current Symposium format to ensure it continues to meet member needs. Although CFNA originally did not plan to host a Symposium this year to support offices attending the National Conference in St. John's, member feedback highlighted the importance of connecting. In response, and with significant effort from staff, we are hosting a condensed 2025 Symposium, while continuing work on a full review of the Symposium model that will lead to a refreshed event in 2026.


Communications have also been a focus, with social media established as a strategic priority and the Network Connections newsletter relaunched to provide consistent updates and engagement with members.

As I reflect on my first year, I am grateful for the support I've received and mindful of the challenges we face. With the guidance of the Board, the commitment of our staff, and the partnership of our member offices, we are building a stronger, more sustainable organization ready to support Community Futures across Alberta well into the future.

ASSET MANAGEMENT

Community Futures Lending & Investment Pool (CFLIP)

Since 2000, the Community Futures Lending & Investment Pool (CFLIP) has provided Alberta's Community Futures offices with a safe and effective way to share resources. Offices with surplus funds can deposit into the pool, while those facing higher loan demand can borrow to meet the needs of their local entrepreneurs.

CFLIP is managed by the Community Futures Network of Alberta (CFNA) on behalf of its members, with oversight from professional fund managers. The pooled structure makes it simple for members to participate: deposits can be made when surplus funds are available and withdrawn when needed. By pooling resources, CFLIP ensures that every office has access to capital when required. This structure strengthens the impact of Community Futures investment funds, supporting more small business loans and rural economic growth across the province.

As at March 31, 2025, CFLIP member investments totaled \$32.8 million (book value), with a market value of \$35.1 million. In addition, the pool included a line of credit facility of \$11.9 million, with \$7.0 million outstanding to Community Futures members.

Regional Relief and Recovery Fund (RRRF)

Launched during the pandemic, the Regional Relief and Recovery Fund (RRRF) provided crucial financial support to small businesses that could not access other programs. Through Alberta's 27 Community Futures offices, millions were delivered in repayable loans to help entrepreneurs keep their doors open, protect jobs, and adapt during a time of crisis.

Today, CFNA manages the returned funds within CFLIP, ensuring they are carefully invested and reinvested so this one-time emergency program continues to provide lasting benefits for rural economic development in Alberta.

As at March 31, 2025, RRRF holdings totaled \$39.4 million, representing repayments from Community Futures offices across the province.

Combined Impact

Together, CFNA manages \$74.5 million in pooled investments at market value through CFLIP and RRRF as of March 31, 2025, with an additional \$11.9 million in credit facilities available to support ongoing lending across Alberta.

TRAINING REVIEW PROJECT (PDRP)

Launched in May 2023 by CFNA and the Professional Development Working Group, the PDRP is reshaping how CF offices receive training. Guided by annual member surveys and feedback, the project aims to deliver a flexible training model to be finalized by March 2026.

Looking Ahead

The final deliverable for the Project is to define the CFNA PD Training Program moving forward. Using findings and feedback from the last 3 years, the goal is to formalize a program for members which provides a consistent annual schedule of quality offerings (due March 2026).



ENTREPRENEURS WITH DISABILITIES PROGRAM

YEAR IN REVIEW

The Community Futures Alberta **Entrepreneurs with Disabilities Program** is designed to make it easier for entrepreneurs with health barriers to pursue their business goals and contribute to economic growth within rural communities.

CFNA-EDP offers individualized support via participating offices for new or existing entrepreneurs who have a self-disclosed physical disability, mental health condition, neurodiversity, or other health condition or impairment which is considered permanent or long-term, and presents a barrier to their self-employment goals.

Program Review

2024/25 was a year of change for EDP in Alberta. We said goodbye to our long-term program manager, Margi Storey, in November. Sue Clynes, CFNA PD & Program Manager, took the helm, kicking her time off with a full review of the program's processes and organization. After a lengthy consultation with EDP coaches, partners, and CF office coordinators and managers, the program was fully refreshed. The new features will continue to be evaluated for success via client and office participation, and feedback throughout the 25-26 program year.
